Dear Bazaar Participant:

The Ukrainian Educational and Cultural Center invites you to participate in our annual Easter Bazaar scheduled for Saturday, April 13, 2019. As in the past years, vendors will not be allowed to sell any food items at all. The Ukrainian Center reserves all rights to all food, baked goods and beverages.

Registration must be in no later than April 6, 2019. We will confirm your registration by placing your name under the vendor list in the Announcements page on our UECC website (www.ueccphila.org).
